1 A non-refundable Administrative fee of \$100.00 will be assessed for each Water Tap Purchase

2 Once a water tap is purchased, the monthly base fee will be charged regardless of water use or meter installation.

3 All separately owned **residential uses***** shall have individual meters and services to each unit from a Company Main

4 The Multi-Family Surcharge applies to each unit above the first on a single water service such as duplexes, apartments, mobile home parks or consecutive systems.

5 Residential units such as apartments, cabins or mobile homes, or consecutive systems which will remain under the same owner in perpetuity are to be charged as Multi-Family uses as in #2 above.

6 The High Elevation User Fee is to cover costs of pumping and maintenance of the higher elevation services on separate pressure zones.

***** Residential uses are defined as townhomes, home, duplex, triplexes, mobile homes, and consecutive systems.**
